First Choice Credit Union is now accepting applications for a \$600.00 scholarship. To be eligible, applicants must:

- Have post secondary plans to attend a 2 or 4 year school.

- Either the student or the parent must be a member at the credit union.

The scholarship is paid in two installments of \$300 (\$150.00 for part time students), the first is paid this year and the second will be paid next year.

Please add this phone number to your contacts so you recognize the phone number when it appears on your phone. **(855-219-5399)** Acknowledging this phone call or message may prevent further fraud on your account and/or having your card blocked from further use.

We also strongly recommend downloading the **BRELLA** app. This is an app that helps you monitor your debit card. This alert allows you to turn your debit card off/on, check your balance, and set alerts for your debit card.
