In addition to having the security of an electronic transfer, you are likely to receive your refund MUCH faster than waiting for a paper check to arrive in the mail. More than half of tax filers now use direct deposit for these reasons.

To direct deposit your tax refund, you will need First Choice Credit Union's routing number (275979393), and your account number. (Please note that your SAVINGS and CHECKING account numbers are different. Contact a Member Service Representative, or Cathy in Bookkeeping to ensure that you are using the correct account number.)

#### IMPORTANT TAX INFORMATION

If you received dividends of \$9.99 or less on your account, you will not be receiving a 1099 for your taxes. That is because the IRS does not require us to send out a 1099 to members who earn \$9.99 or less in dividends. Only members with loans secured by a mobile home or Real Estate will receive a 1098 form. Your interest paid for 2023, will be located on the first page of the December 31, 2023 statement. Please keep this statement until you receive your 1099 or 1098. We will be mailing them out to you by January 31, 2024.

# **HOW TO IDENTIFY A PHISCHING ATTACK**

What is a phishing attack? It is a fraudulent solicitation attempting to acquire sensitive data, like your credit union account numbers, passwords, or other personal information through emails or websites.

Here are 10 Tips to identify a phishing attack through email:

- 1. Don't trust the display name. Always check the email address of where the email came from.
- 2. Look, but don't click! Hover over links. If the link address looks weird, do not click!
- 3. Check for spelling mistakes, or poor grammar.
- 4. Analyze the salutation. Is the subject line vague, such as...to a 'valued customer'?
- 5. Do not give up personal information or send personal information through an email.
- 6. Beware of urgent or threatening language in the subject line. Urgency or fear is a common tactic.
- 7. Review the signature. Lack of identifying information from the sender or company, and / or contact information is missing.
- 8. Do not click on attachments. Malicious attachments may contain viruses and malware. Don't open any attachments you were not expecting.
- 9. Do not trust the header from email address. Fraudsters use logos or brand names to try to look legit. Be cautious!
- 10. Do not believe everything you see. If it looks even remotely suspicious, don't open it. ThreatAdvice 2022 (https://www.threatadvice.com)
